

# Registry Log: Sites listed on and proposed for the Registry of Confirmed Abandoned or Uncontrolled Hazardous Waste Disposal Sites in Missouri.

The Registry of Confirmed Abandoned or Uncontrolled Hazardous Waste Disposal Sites in Missouri (Registry) is maintained by the Missouri Department of Natural Resources pursuant to the Missouri Hazardous Waste Management Law, Section 260.440, RSMo. Sites listed on the Registry appear on a publicly available list, and a notice filed with the Recorder of Deeds documents hazardous waste contamination at the site. Notice regarding contamination must be provided by the seller to potential buyers. The use of a property listed on the Registry may not change substantially without the written approval of the department. The department makes every effort to provide the most complete Registry possible; however, many eligible sites are not yet listed due to pending or ongoing investigations, cleanup negotiations or appeals. Also, unreported facilities or contaminated sites may exist of which the department is unaware.

When the presence of hazardous waste disposal is confirmed at a site, the department notifies the owner(s) of the site that it intends to place the property on the Registry. The notification is sent by certified mail to the owner 30 days before the site is to be added to the Registry. The owner of the site can appeal the proposed placement on the Registry, and no site can be listed on the Registry until the appeal is resolved. If an appeal cannot be resolved through negotiation, the Missouri Hazardous Waste Management Commission may convene a public hearing or assign a hearing officer to resolve the matter. In order to keep the site off the Registry once it has been proposed for listing, property owners may elect to remove the contamination. This is achieved by the owner signing a consent agreement and implementing a cleanup with department oversight. After cleanup of the property is completed, the department will withdraw the proposal to place the property on the Registry.

According to state law, each site listed on the Registry is placed in one of the following categories\*:

Class 1: Sites that are causing or presenting an imminent danger of causing irreversible or irreparable damage to the public health or environment. Immediate action is required.

Class 2: Sites that are a significant threat to the environment. Action is required.

Class 3: Sites that do not present a significant threat to the public health or the environment. Action may be deferred.

Class 4: Sites that have been properly closed and require continued management.

*\*The relative need for action at each site is based solely upon the potential impact of the site on public health and the environment. The type of action required, the feasibility of such an action, and its cost/benefit are not the primary factors in deciding whether action is needed for the purpose of Registry classification.*

*The department publishes the "Missouri Registry Annual Report: Confirmed Abandoned or Uncontrolled Hazardous Waste Disposal Sites in Missouri and Hazardous Waste Remedial Fund Statement" each January.
