NOTICE

Pursuant to Executive Order 09-20, the Director of the Missouri Department of Natural Resources is suspending specific statutes and administrative rules as follows in order to best serve the interest of the public health and safety during the period of recovery following the severe weather and damages associated with flooding, flash flooding, high winds, hail and tornadoes that started on May 8, 2009, and is continuing. This waiver shall be in effect until June 14, 2009 unless otherwise amended by subsequent notice for the counties of Adair, Barry, Barton, Benton, Bollinger, Camden, Cape Girardeau, Cedar, Christian, Crawford, Dade, Dallas, Dent, Douglas, Greene, Hickory, Howell, Iron, Jasper, Jefferson, Knox, Laclede, Lawrence, Madison, Maries, McDonald, Miller, Newton, Ozark Perry, Phelps, Polk, Pulaski, Reynolds, Ripley, Shannon, St. Francois, Ste. Genevieve, Stone, Sullivan, Texas, Vernon, Washington, Webster, Wright and additional counties as deemed by the Director of the Department of Natural Resources.

This waiver was updated May 14, 2009 based on assessments completed by the State Emergency Management Agency. (Original waiver signed May 12, 2009)

Disposal of yard waste

The composting of yard waste is encouraged if it is practical to do so. **Section 260.250.1, RSMo**, normally prohibits the disposal of certain items in landfills. This waiver allows any yard waste generated as a result of the severe weather that started on May 8, 2009, and is continuing, to be disposed of in permitted sanitary or demolition landfill when it is not practical to compost as long as the landfill agrees to accept the waste. This waiver applies only to yard waste as defined in Section 260.200 RSMo, and does not allow disposal of other items normally prohibited in sanitary or demolition landfills.

Burning of woody vegetation

Section 10 CSR 10-6.045 RSMo, Open Burning Requirements, requires a permit for the open burning of vegetative waste that occurs within the corporate limits of any municipality. The Department is waiving this requirement for all areas of the state covered under Executive Order 09-20, with the exception of the Springfield-Greene County area, with the following conditions:

- 1) The vegetative material must be a result of the severe weather that started on May 8, 2009, and is continuing as specified in Executive Order 09-20;
- 2) The vegetative material is burned on the premises where it originated. Central collection points for burning located within the corporate limits of any municipality must receive a permit from the Department. These permits require approval by the local fire officials.
- 3) The vegetative material must be burned at least 200 yards from the nearest occupied structure.



Recycled Paper

Burning within the Springfield-Greene County area must receive a permit from the local air agency or the Department. These permits require approval by the local fire officials.

Open burning outside of the corporate limits of any municipality must take place at least 200 yards from the nearest occupied structure. The 200 yard setback requirement is the minimum required distance; however, greater setbacks may be appropriate depending on circumstances such as the size of the debris pile to be burned. The Department urges local officials to carefully select burn locations taking local air quality, public health and safety, and neighborhood impacts into consideration.

Additional Information
Discharge of water

Section 644.051, RSMo, prohibits the discharge of water contaminants into any waters of the state resulting in a reduction of the quality of such waters below applicable water quality standards. However, the Department is aware that wastewater overflows or bypassing may have occurred following the recent storms. Wastewater treatment plants may bypass or shut down a treatment system or tributary sewer system if necessary to prevent loss of life, personal injury or property damages; or where unavoidable excessive storm drainage or runoff would damage any facilities or processes necessary for compliance with the effluent limitations and conditions of the permit.

The Department will not issue a violation notice to a facility for a bypass or shutdown if at least one of the conditions above is present and provided that the permittee has taken all reasonable actions to prevent bypass. The permittee must make every effort to notify the Department by telephone to the appropriate departmental regional office during normal office hours or environmental emergency response at (573) 634-2436 after hours. Notification should be within twenty-four (24) hours followed by a written report to the appropriate departmental regional office within five (5) days of all bypasses or shutdowns.
